

- Standard Integration tools to import static, accounting and management data from various data sources.
- A Multi Gaap Accounting Referential with various types of accounts, transaction types, journals, etc.
- Flexible definition of the data base structure, this includes the Column dimensions such as Country, issuer, Currency, Product, Maturity, Sector, etc.
- The Database Lines includes Balance Sheet, Profit and Loss, as well as Off Balance Sheet Data.
- It's also possible to add management and statistic data, as well as default values when needed.
- UniQ-RG includes control mechanisms rom one hand to maintain the accounting in balance and from he other to validate captured data.
- UniQ Reporting Engine is able to produce various Accounting related Regulatory reports in various Gaaps.
- All data can be exported to Excel, any third party systems, or accessed with any Business Intelligence tools.
- Files can be created, and sent to any other risk management systems for further calculation and processing.

Our Implementation methodology is presented as follows:

- 1. Scope definition, gap analysis, business and Technical process design,
- 2. Parameter and solution build release one,
- 3. Key user training, validation scenario definition and execution,
- 4. Parameter review and solution build two,
- 5. End user training, acceptance test definition an execution.
- 6. White Migration strategy and execution,
- 7. Parameter review, and production solution build,
- 8. Conversion strategy and execution
- 9. Follow-up and post go live accompaniment.

New releases are issued either on request for corrective maintenance or yearly for preventive maintenance. The later one is made to improve performance and to cope with regulation changes.

We recommend to our customers to upgrade at least once every three years.

Our Challenges

- Changes in processes, functions, and features can be required either by management needs or by regulation constraints.
- UniQ Service and Product teams, will asses the feasibility of the changes based on customer change requests. And new releases are issued for upgrades.
